- Practice exam questions

THE CGEIT EXAMINATION

Please note that the CGEIT exam is not included in this training course. CGEIT exams take place in June and December each year and you must book the exam directly with ISACA, the awarding examination board.

Our experience shows that delegates have the highest chance of success if they sit the exam approximately 2-3 weeks after attending this training course.

ARE THERE ENTRY REQUIREMENTS?

ISACA requires at least five years of IT governance experience in the five CGEIT Domains to qualify for certification. You can take the CGEIT exam prior to meeting ISACA's experience requirements, but the CGEIT qualification will not be awarded until all requirements are met. We do not set specific entry requirements for this course.
